

TERMS OF TRADE

The Wash

Contract

1. These terms of trade form the contract between Christchurch International Airport Limited trading as The Wash ("The Wash") and The Wash's customer ("you"). The Wash may amend these Terms and Conditions from time to time in its sole discretion.

Fees

2. In consideration for payment of the relevant fees by you ("the Fees"), The Wash agrees to provide the services selected by you ("the Services").
3. In the event that you wish to change the Services initially requested, then you agree that any services subsequently requested and changes to the Services will be deemed to be "Services".
4. In the event that you have not paid the Fees required for the Services (or any part of them) in advance, you agree to pay the Fees on invoice by The Wash.
5. Any Fees not paid on or before their due date will incur interest at the rate of 10% per annum from their due date until the date of payment (whether before or after judgment is entered).
6. Fees may be paid by cash and all major credit cards. In the event of payment by credit card, we reserve the right to charge an appropriate surcharge to compensate us for fees we have to pay to your credit card company in respect of the Fees.

Liability

7. The Wash will perform the Services in a good and workmanlike manner and agrees to exercise all reasonable care when grooming your vehicle.
8. You acknowledge that some Services may require The Wash to move your vehicle to another site.
9. Notwithstanding the above, The Wash accepts no responsibility for any loss or damage to your vehicle while at The Wash or elsewhere whether during the performance of the Services (including self-service Services) or otherwise including but not limited to when being driven by any The Wash's employees.

10. Where it is not possible to contract out of all liability, The Wash's liability is limited to the Fees in relation to the relevant Services.

Abandonment

11. In the event that you leave your vehicle at The Wash and have not uplifted your vehicle from The Wash's premises within 2 days of the agreed date and you have not made alternative arrangements with The Wash for the continued storage of your vehicle, you authorise The Wash to remove your vehicle from its premises and park it on the roadside in the vicinity of the The Wash's premises. The Wash will use all reasonable endeavours to contact you using the contact details provided by you before removing your vehicle in this manner.
12. In the event that The Wash leaves your vehicle on the roadside in accordance with clause 11 above, The Wash will leave your vehicle locked (if the vehicle is reasonably capable of being locked). The Wash will store your key at its premises and your key may be uplifted from The Wash during its business hours on payment of any outstanding Fees.
13. In the event that The Wash forms the view that your vehicle poses a danger to people or property, The Wash may remove your vehicle from its premises and park it on the roadside or at another location determined by The Wash. Unless removal is required urgently (in The Wash's sole discretion), The Wash will use all reasonable endeavours to contact you using the contact details provided before removing your vehicle in this manner.
14. Removal of your vehicle from The Wash' premises in the manner described in clause 11 and 13 above does not relieve you of any obligation to pay the Fees.

Information collected

15. The Wash may retain any information provided by you to assist with future bookings and administer your account, if you have an account with The Wash.
16. You may have access to information we hold about you at any time on reasonable notice, and we will correct any errors in that information as advised by you on reasonable notice.
